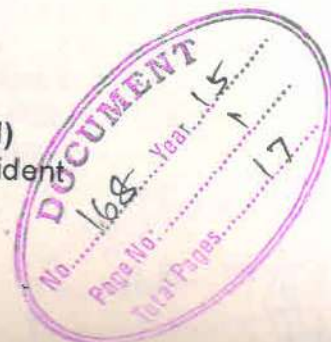

1. **CREATION OF THE TRUST:-**

2. **PROPERTIES VESTED IN THE TRUST:-**

The Trustees do hereby create and constitute a public and social Trust for the objects detailed hereunder and hereby endows a sum of **Rs.1,000/- (Rupees Thousand only)** as the initial corpus fund and the Trustees herein do hereby acknowledge the receipt of the same for achieving the objects stated hereinafter mentioned. Until today No immovable property belonging in the trust name.

3. **NATURE OF THE TRUST:-**

The Trust shall be Educational, Community, and Economic Trust, having no commercial or profit motive. The properties, securities, moneys and income or profits thereof shall be applied in India solely for the purposes of the Trust without any discrimination of race, religion, caste, or sex and no portion thereof shall be distributed among the Trustees.

4. AIMS AND OBJECTIVES:-

5. To undertake directly or indirectly studies, research assignments, action research project, training programmes, project accompaniment, monitoring and evaluation assignments for the Government State or central, Aid agencies and Non-Governmental Organizations.
6. To undertake all kinds of rescue, relief, resettlement and rehabilitation programme at the time of natural and other calamities and involuntary displacement.
7. To bring out study reports, research findings, bring out newsletters, document monitoring and evaluation reports etc., in support of the other objects of the Trust.
8. To undertake rural and urban educational and health activities.

9. To establish street children, orphans destitute, old age, child labour homes, Schools and Colleges in urban & rural areas.
10. To organise women awareness camps, centres for destitute women.
11. To promote legal training programmes and assistance to victims. Also mobilise various Government programmes.
12. To provide vocational trainings for school-drop outs and other dalit men and women.
13. To mobilise economic programmes. Promote companies for Micro Credit for women.
14. To borrow money on interest from RMK, NABARD and other Financial Institution and to lend to the women groups and collect the repay to the concerned institutions; raise loans from banks, Govt, Financial Institutions for purposes of Trust.
15. To promote slum development activities.
16. To take up any other activities or programmes to achieve the objectives of the trust.
17. To produce and distribute educative materials for the promotion of the objectives of the trust without any motive for profit.
18. To develop and distribute educative materials to promote love and brotherhood as well as good values of life among various peoples and communities.
19. To educate the alternative medicine.
20. To free camp for poor people in rural area.
21. To impart useful and educative information in all matters affecting social, economical, cultural and scientific life to the public in general and particularly to the ignorant people of undeveloped remote villages, urban, town and to youngsters to make them better citizens.
22. To start and run, maintain, manage administrative. Alternative medicine and Paramedical Training Institutions. Industrial training Institutes, Industrial Training Centre, Polytechnics, Schools, High Schools, College Diploma Courses, NCVT and SCVT Approved Training / Centres / Institutes. Approved Degree / Diploma Courses etc. any where in India.
23. To effectively organise functional literacy adult education, programme, Non-formal education and social awareness with the assistance and resources from the Govt. of India and Govt. of Tamil Nadu (or) without resources through animators.
24. To open training centres for village level animators, motivators, and health workers.
25. To promote health programme, teach and propagate preventive health care, health education, family planning, immunisation programme etc.
26. To start and maintain hospitals, medicals, non-medical colleges, medical diploma courses, Nursing Training Colleges and Other Medical Technical Training Courses etc.

27. To start Women Sangams and conduct Women's Awareness Meetings.
28. To promote Women's Education, this service of the trust shall be extended to all people irrespective of caste, religion and sex.
29. To conduct environment programmes.
30. To conduct AIDS Awareness programmes to start AIDS Counseling Centers to spread the message of HIV / AIDS (through meetings, Posters, Dramas, Medical etc.)
31. To open handicraft centers for boys and girls and to teach them useful handicrafts like carpentry, typewriting, tailoring basket making, computer training, cotton and silk weaving, and small cottage industries such as mat-weaving paper making to open and maintain short term technical and non technical course and trainings.
32. To conduct children's programme and eradicate child labour
33. To start vocation training centers for women and men and start nursery schools for children's.
34. To start prevention of Drug abuse centers.
35. To Start maintain and manage formal or non formal schools colleges, evening and Day colleges Training Schools.
36. In collaboration with government and other agencies to open orphanages and hostels.
37. To start adult education and non-formal education and run high schools for the benefit of illiterate adults.
38. To open physically handicapped deaf, and dumb, schools and conducted programmes.
39. To help leprosy people and open leprosy centers.
40. To render financial help to physically handicapped persons destitute and widows.
41. To open through India level, and give paramedical, Medical Engineering, Polytechnic, Homeopathy, Siddha, Dental, Pharmacy, Nursing, Teacher Training, General Education, Computer Education both Hardware and Software, Catering, Arts and Craft, Agriculture, Environmental Service, Forestry, Horticulture, Arts and Science Collège, Vocational Education, Primary, Nursery Education Schools, Middle and Higher Education, Industrial and Typewriting, Professional Education like law, etc., and to develop the education in the state solely for philanthropic purpose and not for any gain or profit.
42. To run non- Formal education centers or other institution or Institutions for the down- trodden people of India, solely for philanthropic purposed and not for the purpose of any gain or profit.

43. To promote the interests, all - round welfare of all the socially educationally and economically weaker section of peoples of India.
44. To bring together and co-ordinate the activities or and affiliate organizations working for the people.
45. To help the unemployment and underemployed youths in all possible ways in order to make them self reliant and self supportive.
46. To run Hospitals, Health Education Centers and Primary Health Centre or Institutions for the reception and treatment of persons suffering from illness or mental defectiveness or for the reception and treatment of persons during convalesces or of persons requiring medical attention of rehabilitation solely for philanthropic purpose and not for purposes of any gain or profit.
47. To study the problems of Indian people and focus attention on them
48. To enable the socially, educationally and economically downtrodden people of India to realize and fulfill their responsibilities in themselves, in society to the country.
49. To identify the Bonded Labor and to take step measures to, redeem them and providing helps for the self reliant of them.
50. To conduct periodical lectures, meetings, workshop, seminars, conferences, seminars and surveys, talks, discussions and debates, symposia, competition, research, sports and games, Audio-Visual programs, cultural activities, education camps or matter of interest to national people.
51. To provide a medium for the exchange of information about the activities objectives and experience of similar organization.
52. To establish, open or take aver and maintain educational Institutions for normal and or for the Deaf and Dump, the mentally retarded, the visually disabled otherwise called as Blind, and other Physically disabled children and adults or like institutions for the General Welfare of the public.
53. To assist in developing the target community of those affected by poverty, oppressions or gender, in the social, developmental, economic, legal, human right, health, medical, educational, environmental, access to resources, natural resources development, Panchayatraj and other field of work directed at people in need and to empower them.
54. To assist the target community to develop their activities in the respective fields of work directed at people in need.
55. To identify, Mobilize and provide services and resources to target community which may include training, constancy, funding and non-funding support, assistance with fund raising and routing of funds, monitoring and evaluation, program development, research and student recruitment and other services required by them.
56. To search and engage in lobbying and advocacy and use any other legal and constitutional means for the social, economic and political and other rights of people in need, vulnerable groups and others.

57. To lobby government and other agencies to provide facilities programs, funding, etc., to target community with whom community associated and other genuine organizations.
58. To tackle the linked problems of economic developments and protection of the environment.
59. To bring about National Integration and International Understanding and strive for harmony and peace among various castes, creeds and races.
60. To examine ways and means to promote and protect efficiently the rights of persons belonging to national of ethic, religious and linguistic minorities.
61. To promote the basic concept of human rights as enshrined in the Universal Declaration of Human Rights.
62. To reassert that women's human rights or indivisible and universal and to challenge the development policies affecting the rights of women.
63. To prevent the exploitation of children and to enforce the rights of children and also to work towards abolition of child lab our.
64. To ensure the full and free participation of scheduled caste and scheduled tribe people in all aspects of society in particular in matters of concern, to them.
65. To conduct experiments and research in the sphere of development models.
66. To help the women in all possible ways in order to make them self reliant and self-supportive.
67. To publish books, journals, periodicals, new bulletins, tracts, pamphlets, posters and other relevant materials other than registered newspapers, and to produce short films, slides stories and like to attain the aims and objectives for private circulation.
68. To establish and maintain documentation centre's, libraries and reading rooms for information dissemination, research and reference.
69. To establish and maintain endowment funds for providing scholarship, loans, books and reading materials etc., to the students from weaker sections of the society.
70. To affiliate to any local, national and or regional and or international organizations including the specialized agencies and or to cooperate with them in all matters concerning the common interest and welfare of the National weaker sections of the society.
71. To manage and make better use of natural resources and protect and improve the environment and to develop sustainable agriculture, horticulture, forestry, wild animals, Birds, water management, animal husbandry access to land, water, forest, local resources etc., and related and other related urban and rural activities.
72. To start research and intervention program on reproductive health care and also to publish reports and to form full-fledged Maternity care centre.

73. To form self-Help Groups and a Federation of self-help Groups of the women and men.
74. To network with like-minded organization for joint action and to provide a common forum for such organizations to share experience and learn from one another, develop a common and more empowering approach.
75. To improve the quality of life in general ensures proper access to basic cultures and to promote cultural and recreational activities, and facilitate people to claim their rights and entitlements perform their civic duties and to co-operate in community action.
76. To educate about the siddha medicine and other alternative medicine and about the usage of herbal in curing the diseases and conducting the medical camp in the villages through the well trained doctors with the intention to give medical relief to the poor public.
77. To give training in siddha medicine to the unemployed youths in the villages in under to give First Aid to the public who ever suffering from the diseases and to give training to collect the Herbal's from the Hills and Forest and make use of it and to sell the products made from the Herbals and also the raw herbals.
78. To prevent any diseases, to create peaceful atmosphere, to advice for the good character, love and affection with the all human beings and to have good relationship in the society and for which to train yoga, meditation and breathing exercise daily or monthly and also give training to teach the same to other general public.
79. To educate astrology, vasthu, to teach the method of prayer in the temple, church, mosque, etc., and to create awareness among the public through the Press and other Media's.
80. To provide vocational training to the unemployed youth who ever discontinued their education in the villages and to give software and hardware training for them to seek self-employment and to send the said trained persons to the companies, organizations for placement.
81. To establish and run home for aged, destitute widows, disabled handicapped persons, mentally retarded orphanage and to give training including handicrafts training and to make all arrangements to sell the products made by them.
82. To give shelter and make all arrangements to treat to the Aids patients, patient affected with leprosy and other diseases.
83. To provide all sort of help including financially, economically and morally to the public who ever affected by natural calamities including Tsunami flood and earthquakes etc.,
84. To create awareness and usage of natural fertilizer instead of chemical fertilizer through the technology and other latest method adopted in the foreign countries.

85. To give medical treatment through the doctors to the cattle and animals in the villages and conduct veterinary camps in the villages in order to give proper treatment for the diseases suffered by the cattle's and other animals in the villages.
86. To plant the trees in the villages and in the forest and to make use of the waste dry lands by getting proper approval for the government and to educate about the usage of non-conventional energy, solar energy.
87. To establish, Computer Training Centre, Training Centre, and allied education institutions.
88. To Spread for promotion of education and learning in all branches more specifically in Science and Technology.
89. As All Districts with herbal cultivation, agriculture as their major occupation, regular awareness programmes, training programmes, development of crop growers based associations and marketing network will be developed for the betterment of the formers.
90. To undertake all type of agriculture and animal husbandry in the waste land project.
91. To promote and upgrade the trucks agricultural through various Medias to reach the news to the poor farmer.
92. To provide all type machineries and equipments, trucks, that are needed to develop the agriculture to the farmer.
93. To open trucks and farmer clubs.
94. To create credit linkages to promote the agricultural and animal husbandry.
95. Any other activities that are needed to the development of agriculture and animal husbandry through the State and Central Government.

5. THE NAME OF THE TRUST AND ITS ADDRESS

The name of the TRUST shall be

"GREEN VALLEY EDUCATIONAL TRUST" Its office shall be at presently located at **6/3, Ashraf Street, Pernambut, Vellore - 635 810 Vellore District.** and subsequently at such places as the Trustees may decide from time to time anywhere in India.

6. BOARD OF TRUSTEES :-

6.1 The Trust shall be administered by a Board of Trustees consisting of 3 permanent Trustees. The permanent Trustees may nominate / co-op not more than 9 additional Trustees.

- 6.2 The above-mentioned Founder cum President, Secretary and Treasurer shall be the first trustees of the foundation and permanent of the same. They shall hold office for life or until resignation.
- 6.3 The additional Trustees shall hold office for a period of 3 years from the date of their nomination. The retiring Trustees shall be eligible for re-appointment.
- 6.4 On the death or resignation of a permanent Trustee the remaining permanent Trustees shall appoint a new permanent Trustee in his/her place.
- 6.5 The permanent Trustee decided in the General Body Meeting and shall be elect a Founder cum President a Secretary and a Treasurer from among themselves to hold office for a term of three years. They shall be eligible for re-appointment.

7. BANK ACCOUNTS :

All Bank accounts opened in the Trust Name shall be operated by Founder cum President and Secretary of the Trust, who shall be authorized by the Executive committee.

8. POWERS OF THE TRUSTEES :-

The Founder cum President shall be the chief executive of the foundation and shall have the general power to conduct the affairs and management of the foundation.

The Secretary and Treasurer shall exercise such powers as may be delegated to them by the board of trustees.

The Trustees shall have full power and authority to administer the trust its institutions properties and funds and to do all acts deeds and things as are calculated to promote the objects for which this foundation is established. They shall be entitled to act even if their member is reduced to less than five for the purpose of filling up any vacancy in the Board of Trustees.

Without prejudice to the generality of the foregoing the trust shall have the following powers and authorities for the purpose of this trust.

- a. To invest the funds if the Trust in accordance with the provision of section 13 (l) (d) read with section 13(5) of the Income Tax Act, 1961.
- b. To acquire by purchase, gift, exchange, lease hire or otherwise lands, buildings, movable and properties of every other descriptions.
- c. To sell mortgage grants lease hire or otherwise alienate the proprieties of the trust.
- d. To borrow money with or without security and repay the same.

- e. To enter into all contracts on behalf of the trust and to vary and rescind them.
- f. to open bank accounts and provide for their operation as the Trustees may deem fit from time to time.
- g. To receive gifts, grants, endowments and donations in cash or in kind from person's institutions and authorities within India and outside India.
- h. To raise money from the public by organizing benefit performance collection and subscription and donations bringing out publications and in other ways.
- i. To institute, prosecute and defend all suits/ legal and other proceedings.
- j. To appear and act before Courts, Tribunals, Governments, Tax and Public authorities.
- k. To appoint, terminate, dismiss, suspend and otherwise deal with the employees of the trust and its institutions.
- l. To apply the properties and funds of the Trust for all or any of the objects for which the Trust is established as may be determined by the Board of Trustees from time to time.
- m. To decide from time to time the works to be undertaken in fulfilling the objects of the trust.
- n. To incur all the necessary expenses connected with the trust and its projects.

9. PROCEEDINGS OF THE TRUST :-

The Trustees may meet as often as may be necessary for the conduct of the business of the Trust

The quorum required for a meeting of the Board of Trustees shall be two. In the case of meeting adjourned for want quorum the members present shall themselves constitute a quorum subject to a minimum of two.

The Founder cum President and in his absence or inability any other trustee elected as the Chairman shall preside over the meeting of the trust.

All decisions of the Board of trustees may be taken by a simple majority except as expressly provided for otherwise herein. The Trustees of the meeting shall be entitled to a casting vote in the event of equality of votes at a meeting.

At least one week notice in writing shall be given for every meeting for the Board of Trustees provided however The Trustees shall have power to convene a meeting at shorter notice for transacting any business considered by him to be urgent.

The business of the trust may also be transacted by circulation of papers.

The Founder cum President shall maintain the proper record of minutes of the Board of Trustees.

No vacancy of the Board of Trustees and no irregularity in appointing any trustee shall invalidate any act or decision of the Board of Trustees.

10. DELEGATION :

The Board of Trustees may from time to time delegate to one or more of their body or any other person or committee/s such of their powers and duties as they deem fit, subject nevertheless to their retaining ultimate control and supervision.

The Trust may constitute an advisory body at Regional / National level with eminent men as its members and seek their advice regarding the activities of the trust keeping the objectives of the trust in perspective.

11. FRAMING OF RULES AND BY-LAWS

The Board of Trustees may frame rules and by-laws for the management of the trust, its institutions, properties and proceedings of the trust and amend or rescind them as it deems fit.

12. ACCOUNT AND ACCOUNTING YEAR:-

The trust shall maintain account regularly. The account shall be audited by a Chartered Accountant every year according to legal requirements.

The year of the account of the trust shall be from the first day of April of a year to the 31st day of March of the following year.

13. AMENDMENTS OF THE TRUST DEED:-

The trustees shall make such amendment as they find necessary to the Trust deed and the rules and regulations within the frame work of the Trust but no amendments of the Trust deed or rules and regulations shall be made which may prove repugnant to the provisions of the section 2(5)11-13 and 80G of the Income Tax Act, 1961. That is not contravening the provisions of the Income Tax Act applicable to Charitable Trust.

14. INVESTMENT OF TRUST FUNDS:-

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall be transferred to another charitable trust, society, association or institution, whose objects are similar to those under section 80 G of the Income Tax Act, 1961.

15. INDEMNITY:-

The Trustees shall be kept indemnified and harmless by the Trust against any action, claim, demand or liability arising against them for anything done by them in good faith, pursuant to the power of authority vested in them under these presents.

16. IRREVOCABILITY AND AMENDMENTS TO THE TRUST.

16.1. The trust hereby created is irrevocable.

16.2. The provisions of this deed may be amended if the Board of Trustees an unanimously or by not less than 3/4th majority so decide.

16.3. It is hereby made clear that the Board of Trustees shall have power to make from time to time all such amendment as may be required to secure recognition , exemptions and relief under Income Tax Act or other fiscal laws or as may be found necessary for the smooth working of the trust.

16.4. Provided that the character of the Trust as a public charitable trust shall not be altered.

17. "SPECIFIC CLAUSES OF INSTRUCTIONS RELATING TO THE INCOME TAX ACT" should be amended.

- The Institution is irrecoverable
- In case of winding up/dissolution, the net funds would be transferred to institutions having similar objects and enjoying exemption under S.11 and 80G of the IT Act, 1961;
- Any amendment to the instrument would be carried only with the approval of the commissioner of Income Tax / DIT (E) Chennai;
- The activities would be continued to the territory of India;
- The activities would be of purely charitable / religious nature not motivated for profit;
- The funds of the institution would be utilised only towards the objects and no portion of the it would be distributed in any manner to the trustees or persons defined in sec.13(1) (c) of the Income Tax Act, 1961;
- The benefit of objects would be available to the general public irrespective of caste, creed, religion or sex;
- The funds of the institution would be invested as per sec. 11(5) read with sec.12(1) (d) of the Income Tax Act 1961;
- The accounts would be maintained regularly and would be audited by a Chartered Accountant [Expln. to sec 288 (2)];
- Not more than 5% of the income of the trust / institution would be applied for any religious purpose or given to religious institutions;
- Alienation of immovable property shall be done only with prior approval of the Director of Income Tax (Exemption) Chennai / Commissioner of Income Tax.



18. DISSOLUTION AND DISTRIBUTION OF ASSETS

If at any time the continuation of the Trust shall appear to two-thirds for the trustees for the time being not to serve any useful purpose the trust shall forthwith be wound up and any asset remaining after the satisfaction of all lawful liabilities and claims against the trust the same shall under no circumstances be paid to or distributed among the trustees, for the time being or former TRUSTEES or made available for personal benefit of any one shall be given to some other registered society, trust, association or institution or non-profit company (whose objects are similar to this trust and which enjoys registration as per income tax act) to be determined by two-thirds of the TRUSTEES for the time being or in default thereof by the court of law having jurisdiction in the manner. **Until today No immovable property belonging in the trust name. We wish to Register this Deed of Trust at Vellore District Registrar Office.**





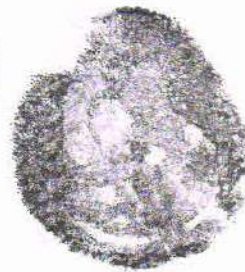
